The Youth Wrestling Program is designed for all wrestling skill levels from kindergarten through 8th grade.

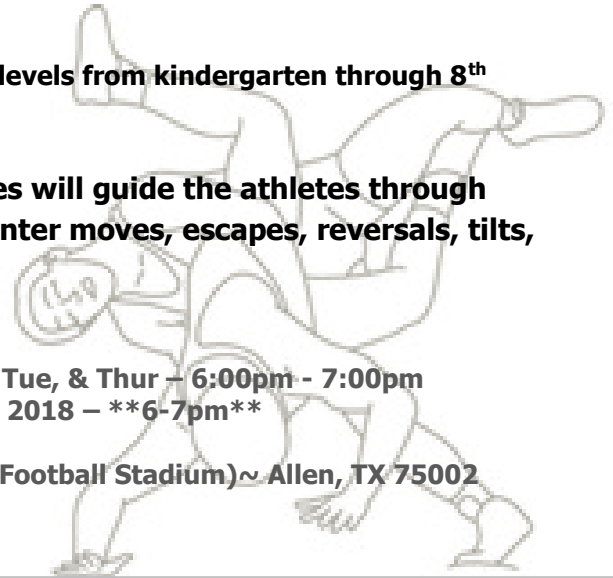
